## STANDARD EQUIPMENT

**Free time: 10 CALENDAR days, as from day of arrival / discharge port Kralendijk (discharge date included) until empty container returned at port of Kralendijk, Bonaire.**

Day 11 up to 19 USD 25.00 per 20' unit per day & USD 35.00 per 40' unit per day.  
Day 20 up to 999 USD 35.00 per 20' unit per day & USD 55.00 per 40' unit per day.

## SPECIAL EQUIPMENT

**Free time: 7 CALENDAR days, as from day of arrival / discharge port Kralendijk (discharge date included) until empty container returned at port of Kralendijk, Bonaire.**

Day 8 up to 19 USD 35.00 per 20' unit per day & USD 50.00 per 40' unit per day.  
Day 20 up to 999 USD 45.00 per 20' unit per day & USD 70.00 per 40' unit per day.
